## Bengaluru: two doctors arrested for 'killing' man

Bengaluru: Days after a 53-year-old businessman went missing from Gokak town in Belagavi district, police have found that two doctors had allegedly killed him over a financial dispute.

The victim has been identified as Rajesh Zawar and the accused are Dr Sachin Shankar Shiragave (36), Dr Shivanand Patil (28) and Shapath (25), a mechanic. Police suspect around 5-6 persons are involved in the murder. Investigation revealed that Dr Sachin had taken a Rs 70 lakh loan from Rajesh and there were some differences over repayment. The police found that Dr Sachin was active in the places where Rajesh's mobile phone was active. After being taken into custody, Dr Sachin reportedly confessed to the murder. **ENS**
